**Sub: Provisional Extension of affiliation upto 31.03.2020-reg.**

Sir/Madam,

This is with reference to the Periodical Inspection of the school held on 29.10.2018 on the subject cited above.

In this connection, I am directed to inform that on scrutiny of the report submitted by the Inspection Committee (copy enclosed), the following deficiencies have been observed:-

1. The school is maintaining its Statement of Accounts in the name of the Society /Trust running the school whereas the school is required to maintain the same in the name of the school itself.
2. Enrollment is high in few classes whereas the school is required to restrict its enrollment to upto 40 students per section as per norms of the Board.
3. The school is required to submit Recognition Certificate for running classes' upto VIII from the Competent Authority of the concerned State Government.
4. It has been observed that the school is having 20 sections and for which there are only 20 teachers in the school whereas the school should have at least 30 teachers in order to maintain section teacher ratio as per norms of the Board. Therefore, the school is required to appoint 10 more trained and qualified teachers as per norms of the Board.
5. The school has submitted the expired copy of the Fire Safety. Therefore, the school is required to submit the renewed copy of the same as per norms of the Board.
6. The school has not submitted the copy of the Building Safety from the concerned authorities. Therefore, the school is required to submit the same as per norms of the Board.

However, in view, the academic interest of the students, I am directed to convey approval of the competent authority for provisional extension of affiliation upto 31.03.2020 alongwith permission for registration of bonafide candidates of class IX / XI and submission of list of existing candidates of the School for class X and XII for current session.

However regularization of affiliation from 01.04.2017 for a period of 05 years will be subject to the submission of compliance/documents observed above. All the documents forwarded to the Board must be signed by the Principal and Manager of the school.
